2. I, hereby, undertake to present the original documents immediately upon physical presence at the university to the concerned authorities of the university.
3. I hereby promise to abide by the rules and regulations concerning admission, attendance, discipline etc. of SAU and follow the Code of Conduct prescribed for the Students of SAU including law of the land as in force from time to time and subsequent changes/modifications/amendments made thereto. I acknowledge that the SAU has the authority for taking punitive actions against me for violation or non-compliance of the same.

I hereby declare that I shall be solely responsible for my involvement in any kind of unlawful activities whether inside or outside the campus, and shall be liable for punishment as per the law of the land. I further understand that the University shall in no way provide any support to me and will not be held responsible for my any such action.
7. I hereby acknowledge that I shall be liable for expulsion forthwith from the SAU on being found involved in or committing any offence cognizable and punishable under the Narcotic Drugs and Psychotropic Substances Act, 1985.
8. I also declare that I am not suffering from any chronic disease.
9. If required, I will seek medical treatment as per my eligible insurance coverage in accordance with the rules & regulations of the university.
10. I further declare that my admission may be cancelled, at any stage, if I am found ineligible and/or the information provided by me are found to be incorrect.
11. I hereby undertake to inform the University about any changes in information submitted by me in the Application Form and any other documents, including change in addresses and phone nos., from time to time.
12. I will strictly adhere to the code of conduct as laid down by the Student's Conduct and Discipline Rules and Hostel Rules and Regulations and shall not indulge in any act of indiscipline while inside or outside the University campus.
